# Conditions of a Housing Crisis Response System

- Rare, Brief, & One Time
- Person-centered
- Data-informed



## A System to End Homelessness

- Divert people from becoming homeless
- Prioritize those with highest needs for housing
- Quickly engage people in the least expensive intervention to end their homelessness
- Short lengths of stay
- High rates of permanent housing exits
- Use data to achieve continuous improvement



Achieving a Housing Crisis Resolution System Requires Analytic Work

- Assess what the existing homeless system and programs are accomplishing
- Identify what is working and what needs improvement
- Determine how much of what needs to change given available resources



### Performance Measures

- 1. HMIS Data Quality
- 2. System Capacity in Relation to Need
- 3. Bed/Unit Utilization
- 4. Entries from Homelessness
- 5. Length of Stay
- 6. Exits to Permanent Housing (PH)
- 7. Cost per Permanent Housing Exit
- 8. Returns to Homelessness



## Typical System Analysis Results

- Data quality compromised in certain programs or fields
- Array of programs/interventions not precisely matched to populations
- Rapid re-housing outperforms transitional housing
- Within program types, superstars and low performers
- Across program types, highest need households not prioritized and served/housed
- Returns to homelessness not significant issue









- Outcomes-oriented: Cost per permanent housing exit


