

## Summary of Federal & State of California Funding Sources for COVID-19 Homelessness Response

**Updated April 15, 2020**

This table assembles available information on federal and State of California funding sources that are being made available to local entities to address the COVID-19 pandemic among people who are experiencing homelessness or at-risk of homelessness. New information is being released almost daily, so this table will be updated on a regular basis.

\*HEAP and HHAP are not included on this table, since they are not specifically COVID-19 sources. However, the State of CA is allowing communities to use these sources for COVID-19 response, should the community determine this is a priority use of the funds.

### USES OF FUNDS

- Intent: “To prevent, prepare for, and respond to coronavirus, among individuals and families who are homeless or receiving homeless assistance and to support additional homeless assistance and homelessness prevention activities to mitigate the impacts created by coronavirus”
- Eligible Service Uses:
  - Temporary emergency shelter (through leasing of existing property, temporary structures, etc.); not subject to minimum periods of use requirements
  - Limited environmental review (need State or local health official approval, Federal habitability and environmental review standards and requirements don’t apply)
  - Training on infectious disease prevention and mitigation
  - Hazard pay for staff working directly to prevent, prepare for, and respond to coronavirus among persons who are homeless or at risk of homelessness
- Funded services may not require treatment or requirement of prerequisite services as a condition to receive shelter, housing, or other services
- Up to 10% for administrative purposes
- Up to 1% for technical assistance providers with experiencing in provided health care services to people experiencing homelessness
- Recipient award decisions not subject to consultation, citizen participation, or match requirements: however, do need to publicly publish how recipient has/will use allocation

### USES OF FUNDS

- Intent: To support infectious disease response; can be used for broad range of activities, including those that support people experiencing homelessness
- Examples of Eligible Service Uses:
  - Acquisition, construction, or rehabilitation of buildings for testing, treatment, or temporary isolation for recovery from Covid-19
  - Assistance to businesses, including special economic development assistance, to create jobs/manufacture supplies necessary to respond to Covid-19 or to support microenterprises that support home health and quarantine
  - Public services, including rental assistance, operating costs of shelters, etc.
  - Planning, capacity building, technical assistance
- No public services cap (unlike regular CDBG)

### USES OF FUNDS

- Intent: To supplement HOPWA grantee expenses to prevent, prepare for, or respond to COVID-19; to be used to maintain operations and for rental assistance, supportive services, and other necessary actions related to COVID-19
- Examples of Allowable Uses for HOPWA Eligible Households:
  - Assistance in accessing essential services and supplies
  - Education on infectious disease prevention and methods of reducing spread of infection
  - Transportation to access medical care, supplies, food, or commute to employment
  - Nutrition services in form of food banks, groceries, meal deliveries
  - Lodging in hotels, motels, etc. for purpose of quarantine
  - Homelessness prevention in form of short-term rent, mortgage, or utility payment assistance
